Interior renovations and full window and door replacement including modifications of openings on the north and east facades.

The board prefers for replacement of windows on historic home to be in-kind (same size, style and lite configuration), but if not, then one over one is preferred over snap in grills, grills inside panes, or changing to a different style altogether.
